## 12. SPECIAL RESOLUTIONS: Matters relating to the Incorporated Societies Act 2022 and seeking membership approval to re-register with the Incorporated Societies Register

#### Background Information:

The Panmure Business Association was incorporated as a society on 25 January 1952, under the Incorporated Societies Act 1908, originally named the Panmure Commercial Association Incorporated. On 11 March 2015, the name was changed to Progressive Panmure Business Association. Subsequently, on 1 June 2020, it was renamed to its current title, Panmure Business Association Incorporated.

On 5 October 2023, the Incorporated Societies Act 2022 (the 2022 Act) came into effect. This new Act modernizes the laws governing societies, and for a transitional period, both the 1908 Act and the 2022 Act will be in force. Societies incorporated under the 1908 Act, like the Panmure Business Association Incorporated, have until 5 April 2026 to re-register under the 2022 Act to retain their incorporated status.

One requirement of the 2022 Act is that societies must have a constitution compliant with the new Act. At this AGM, we are seeking approval from our membership to re-register under the 2022 Act. This involves approving and adopting changes to our current Constitution to ensure compliance with the 2022 Act. We also seek ratification of the updated Constitution from our members, enabling us to re-register before the 5 April 2026 deadline. Failure to re-register will result in the loss of our Incorporated Society status, requiring us to wind up and be removed from the register, which means we would no longer be able to operate as an Incorporated Society

<u>Special Resolution 1:</u> That Panmure Business Association move to approve the Panmure Business Association to re-register with the Incorporated Society Register to keep its Incorporated Society status under the updated Act 2022, before the 2026 deadline.

#### 13. Election of Members to Executive Committee

Rule 13 of the Constitution says that the Executive Committee should:

- consist of an uneven number of members
- no less than five voting members
- no more than eleven voting members
- In recognition of the excellent working relationship that our Business Association has with the elected Maungakiekie-Tamaki Local Board our Constitution includes one Local Board Representative who also has a voting right although they may not be entitled to vote in relation the election of members of the Board or on Auckland Council matters.
- In recognition of the vested interests of Eke Panuku and the Tāmaki Regeneration Company in Panmure, and their continued working relationship with our Business Association, these organisations may be represented by one member and will have voting rights, although they may not be entitled to vote in relation to any matters where there are conflicts of interest.

#### 13. General Business

- a) Security discussions: concerning the effectiveness of current security measures and what the future of crime prevention and security might entail. In particular, having regular foot patrols. The latter is currently in the pipeline for the Christmas period- pursuant to Executive Committee 2024/2025 approval. Budget realities and wider contextual factors cited as key barriers to further development in this space of a sustainable model.
- b) Associate Memberships: discussion around the perceived value of this type of membership. The PBA is responding to wider feedback received from interested parties beyond the current BID boundary. This is an initial step towards a larger strategic expansion.
- c) Restoring external stakeholder meetings: the meetings in question have not been held for years and were run by an organisation that is not the PBA. As the PBA is not the hosting organisation, this particular item is outside the scope of the PBA AGM and not appropriate for this meeting.
- d) Development interests within the town centre: The PBA will continue to disseminate accurate information to the business community on behalf of external organisations with development interests within the town

centre that does not breach commercial sensitivity, has been verified, and with the appropriate permissions given before disseminating.

e) Membership conditions: These are defined within the Constitution.
